Restrictions Filed

Restrictions filed under Harris County Clerk's File No. E624197; Article VII, Section 15.; states "No trucks, trailers, boats, or any vehicle other than passenger cars will be permitted to park on streets on drives in front of residence for longer than a forty-eight (48) hour period."

Restrictions filed under Harris County Clerk's File No. F395956; Article VIII, Section 7, part (d) states "No truck, bus, motor home, boat or trailer shall be left parked in or on the street adjacent to any lot, or in the driveway or on any other portion or any such Lot exposed to public view (except for construction or repair equipment, only while a house or houses are being built or repaired in the immediate vicinity), unless such vehicle is in day-to-day use off the premises and such parking is only temporary, from day-to-day; provided however, that nothing herein contained shall be construed to prohibit the storage of an unused vehicle in an enclosed garage on an Lot."

Vandalism

We have had a significant amount of vandalism in our back park in the past month. It costs \$500 to replace light bulbs each time this has occurred. Someone is taking rocks and throwing them at the lights to bust the bulbs. It also appeared that someone attempted to start a fire on the porch of the Clubhouse. This is coming out of each one of our dues we pay to the Oakwood Glen HOA. There is also graffiti on the back of the storage buildings that will have to be repaired. We have started updating our amenities but with the increase in vandalism this will have to be cut back because of the expense of repairing each time vandalism occurs. If you see anyone around the back park that appears suspicious please contact the Constables so hopefully we can stop this vandalism. We are going to install cameras at the back park very soon and also install them at the front park to protect our community amenities. They will be monitored by an alarm company 24 hours a day and any suspicious activity will be reported to the Constables by this company.


