## Cub Scout Conservation Service Project

I want to inform you and the Oakwood Glen Board of Directors that Cub Scout Pack 1550, chartered by Ehrhardt Elementary PTO, will be conducting a conservation service project in the Spring Creek Forest and Oakwood Glen neighborhoods. We are participating in the Storm Water Inlet Marking (S.W.I.M.) Program. The program involves attaching small medallions to the storm drains to remind people not to dump trash, lawn clippings, oil, chemicals, and other pollutants down the storm drains. We will be placing the medallions between mid-October and Thanksgiving. A limited number of door hangers will also be placed on homes adjacent to the storm drains.

The S.W.I.M. program is sponsored by the Stormwater Management Joint Task Force, which includes the Harris County Flood Control District, Harris County, the City of Houston, and the Texas Department of Transportation. ## Oakwood Glen Information

Homeowners and Residents

I am sure that the majority of you have heard that the Constable's office cancelled their contract with Oakwood Glen. The board has moved with all deliberate speed to replace the contract with another one with the Sheriff's office. The board has been informed that the Sheriff's office will not be able to take over the contract until January, in the interim the board has decided to use the funds set aside for contract patrols for off duty deputies to patrol our neighborhood between now and the end of the year. These patrols will be by Sheriff's deputies and we believe that with an appropriate scheduling and having the flexibility of 4 hour shifts as well as 8 hour shifts we can provide adequate patrol services until the new contract can begin in January of 2008. Since Oakwood Glen does not currently have a contract with any service to provide patrols the responsibility of responding to calls defaults to the Sheriff's office so if you are in need of law enforcement please call the Sheriff's office.

Additionally the board has had three board members resign. The reasons are theirs and I am sure they will be glad to let you know their reasons. What your association needs are homeowners who want to be involved in their community. At the Annual Meeting, October 9th, there were insufficient proxies and/or homeowners to make up a quorum. It is imperative that if you are a homeowner in Oakwood Glen that you attend the next Annual Meeting, November 13th or contact the management company or me in order to get a proxy and mail it in to the management company or let me know and I will come by and pick the proxy up.

Your association also has need of several homeowners who would like to be on the board to attend the next board meeting to let your wishes be known and to present a brief resume type letter setting out your reasons for wanting to be on the board and what specifically you feel you can bring to the board and to your association. Any homeowner who is current on their dues is eligible and is needed. Criticisms has been leveled at various board members concerning certain decisions but please remember that these decisions have to be made and the current board members gather information, discuss and then have to make a decision. It is always hoped that the decision will be correct however there is no way for the board to make every decision that will be liked or approved of by all the homeowners. Your association needs your input, your guidance and your involvement in order to make proper decisions. Please consider volunteering your time and your expertise to participate in your community.
