It's that time again!! The OWG Annual Homeowners meeting. Here is your chance to get involved and run for the board of directors!!! This is the time when you, the members, have the opportunity to talk openly about your complaints, your wishes, your thoughts on how OWG can be a better community and better meet the needs of its members, you.

At the Annual Meeting the members have the authority to vote on the issues set out in the Ballot/Proxy sent to each homeowner. If you have an issue that you believe the entire community should have a say in please let John L. Hill, President of Oakwood Glen Association know and I will put this issue on the Annual Agenda and Ballot so all homeowners can vote on the issue. This is an important meeting and if you cannot attend please be sure you give your proxy to someone your trust to vote in your stead. The ballot that will be sent to all of you contains the names of members in good standing who are running for the board for a three year term. It also contains spaces for write-in names of members who would like to serve a 3 year term on the Board of Directors. This ballot will also include an importance survey which will help provide the board information that will guide them in their decisions about our community. .

The OWG Annual Homeowners meeting must have a quorum present to conduct business; this means that we need 20% of the eligible members, those in good standing, to be present either in person or by proxy. This year we have decided to combine a Fall Festival with the Annual Meeting, there will be food, drinks, information provided by many of the utility providers for our community and by the Sheriff's office, the Cypress Creek EMS and the Klein Fire Department. Please attend and bring you kids, this will be an opportunity to get to know the board members, meet other homeowners and hopefully have some fun!!

All of the current board members will be present at the meeting, as President, it usually falls to me to run the meeting, however the members present may select someone else to run the meeting if they wish.

New traffic, criminal laws set to go into effect Sept. 1

HB 2730 is the DPS's Sunset Legislation, and many of the DPS-related bills this session were included in HB 2730. Notable traffic and criminal laws that go into effect on Sept. 1 (unless otherwise indicated) include*:

Seatbelts:

HB 537 requires **all** occupants of a vehicle, no matter their age, to be secured by a safety belt, no matter where they are seated in the vehicle; changes the definition of a passenger vehicle to include a passenger van designed to transport 15 or fewer passengers including the driver; removes the current exemption for third-party Medicaid transportation provisions regarding the use of child passenger safety seats; and prohibits a motorcycle operator from carrying a passenger under the age of 5 unless the child is seated in a sidecar attached to the motorcycle.

SB 61 amends the existing statute regarding child passenger safety seats. The bill requires that any child younger than 8 years of age be restrained in an approved child passenger safety seat unless the child is at least 4 feet, 9 inches in height. The fine is no more than \$25 for a first offense and \$250 for a second offense. The law also creates a new court cost for conviction of an offense under this section to be collected and used by TxDOT to buy safety seats for low income families. The law becomes effective on Sept. 1, 2009, but tickets for this offense cannot be issued until June 1, 2010. Police officers are allowed to issue a warning before that date.

Driving:

HB 55 makes it illegal to use a wireless communication device in a school zone unless the vehicle is stopped or a hands-free device is used. Cities or counties wanting to enforce this law must post a sign at the beginning of each school zone to inform drivers that using a wireless communications device is prohibited and the operator is subject to a fine. It is a defense to prosecution if the operator was making an emergency call.

HB 2730 increases the penalties for driving while intoxicated with a child passenger by adding an automatic driver license suspension period for first-time offenders and an increased suspension period for repeat offenders. The driver license re-instatement fee for completing an education program will rise from \$50 to \$100. Closes a loophole so a person who commits an offense as a minor cannot circumvent the driver license penalty if the person turns 21 before their court date.



Some of you may have noticed that we now have a Star Bucks in the strip shop located at Louetta and Stuebner -Air line. Try them out!!

They will need the address closet to the pole and the number on the pole. Changing out the light does not cost us anything. The lighting will help to keep our community secure. 

Restrictions filed under Harris County Clerk's File No. E624197; Article VII, Section 15.; states "No trucks, trailers, boats, or any vehicle other than passenger cars will be permitted to park on streets or drives in front of residence for longer that a forty-eight (48) hour period unless used on a daily basis and moved on a daily basis."

Restrictions filed under Harris County Clerk's File No. F395956; Article VIII, Section 7, part (d) states "No truck, bus, motor home, boat or trailer shall be left parked in or on the street adjacent to any lot, or in the driveway or on any other portion or any such Lot exposed to public view (except for construction or repair equipment, only while a house or houses are being built or repaired in the immediate vicinity), unless such vehicle is in day-to-day use off the premises and such parking is only temporary, from day-to-day; provided however, that nothing herein contained shall be construed to prohibit the storage of an unused vehicle in an enclosed garage on an Lot."

FOR INFORMATION ON THE BAN FR COMMERCIAL VEHICLES FROM OVERNIGHT PARKING, FROM 10 PM UNTIL 6AM, PURSUANT TO TEX. TRANSP.CODE ANN. 522.003 (VERNON 1997), SAME CONTAINS A DEFINITION OF A COMMERCIAL VEHICLE.
