A Dalmatian inspired moonwalk and double water slide were a big hit with all the children. Tents set up with misting fans, and coolers full of cold drinks were conveniently located to help beat the heat.

A barbecue lunch, complete with all the trimmings was served in the Clubhouse. Thanks again to resident Carl Mattaliano of Keller Williams, for donating this feast! For the children, a hot dog vending stand topped with a bright yellow and red umbrella was also set up inside to add another choice for all our young party goers. Guests brought desserts and watermelon to finish the meal.

Volunteer judges had a difficult time choosing the winners of the bikedecorating contest. The three winners received Toys R Us gift certificates. This reporter, busy on trash patrol, apologizes for not getting the names of those selected.

One highlight of the afternoon occurred when the Klein firemen unrolled one of the truck hoses and sprayed hot, happy partygoers and our very dry soccer field.

Believe it or not, summer is quickly approaching, and soon you'll be lounging around the pool. The management team of Greater Houston Pool Management, Inc. is delighted to be returning to Oakwood Glen.

Our goal every summer is best defined by our mission statement: SAFETY IS OUR #1 PRIORITY!!! We are also committed to treating our customers with a pleasant and courteous service, as they enjoy their clean swimming environment. We feel communication is the key. Please don't hesitate to contact our office at anytime concerning our service (713) 771-POOL.

To help assure a safe and fun summer for everyone, Greater Houston Pool Management would like to remind you of a few facility and safety reminders:

- Parents must closely supervise their children at all times. Remember, it only takes seconds for a child to drown.
- 2. Don't allow children to play with or around the main drain. The main drain suction can be very powerful, and has been known to cause severe injuries, and in some cases death.
- 3. The safety of the children in the baby pool are the parents or guardians responsibility. The lifeguards will always enforce the pool rules throughout the facility, but children who cannot swim must have an adult within arms reach at all times. The same rule applies even if the child is wearing a floatation device.
- 4. Define a safe zone for your children where they can always touch the bottom. One of the most common saves a lifeguard must make is when a swimmer strays to an area that is too deep for them to stand.
- Do not dive in areas marked "NO DIVING". Nearly 90 percent of all spinal injuries occur in the shallow end of the pool.

- Breath holding games can be very dangerous and may cause cardiac arrhythmia or seizures. Games like who can hold their breath the longest, and swimming the longest distance underwater should be avoided at all times.
- Pool passes will be strictly enforced. It is the member's responsibility to bring them to the pool. It is a very awkward and uncomfortable situation for everyone, when the lifeguard must ask a member to go back home to get his or her pool pass.
- Remember that there are several different types of people who like to use the pool throughout the summer. Both young and old, everyone wants to have a good time.
- 9. If you should ever have a question about the pool rules, ask a lifeguard or manager. It is better to be safe then sorry!!!
- 10. Have a safe and enjoyable summer.

TEXAS "LIVING WILL" INFORMATION

With recent news articles on living wills, all of us need to know what to do here in Texas to locate and validate such a document if we so desire.

The Houston Chronicle, in a column by Ronald Lipman advises:

You can obtain the form on the Internet by visiting www.capitol.state.tx.us. In Texas, a living will is actually called a Directive to Physicians and Family or Surrogates.

Once there, click on Statutes and then on Health & Safety Code. The form is contained in Section 166.033. Most hospitals will give you

The board passed a motion to obtain new aluminum goals and safety nets for the soccer/sports field. Plans continue to straighten the field so it can be 5. A resident suggested soliciting even better for all our boys and girls.

AUGUST RECIPE CORNER

BLT Macaroni Salad

Try this easy, tangy crowd pleaser. Tastes great as a side dish for a barbecue.

2 cups elbow macaroni

5 green onions-finely chopped

1 large tomato-diced (or substitute small cherry tomatoes-halved)

1+1 /4 cup diced celery

1+1 /4 cup mayonnaise

5 tsp. White vinegar

1 /4 tsp. Salt

1/4 tsp. Pepper

1 lb. Bacon-cooked and crumbled

Cook macaroni per package directions. Drain. Rinse in cold water. In a large bowl, combine the macaroni, green onions, tomato and celery. In a small bowl, combine mayonnaise, vinegar, salt and pepper. Pour over macaroni and toss to coat. Cover and chill at least 2 hrs. Just before serving add bacon. Serves 12. - M.Harris

SPECIAL BOARD MEETING

President John Hill called a Special Board Meeting on June 27th at 7PM in the Back Park. This replaced the original second Tuesday of June meeting, as not enough directors were present to establish a quorum for voting.

Issues discussed:

- 1. The Board approved 6 ceiling fans to be installed at the Front Park by Trim Electric.
- 2. Work on the Bylaw changes is still ongoing. Mr. Gainer, OWG attorney, had a death in his family, so he is still reviewing proposed revisions. The possibility of delaying the Annual Meeting until October was mentioned to assure there is ample time for all residents to review any changes before voting. These changes will be mailed out to all before Annual Meeting takes place.
- Discussion on adding covered pavilions at the Front Park so more residents can enjoy the facilities and have cover in case of sudden thunderstorms. Design would be similar to those at Meyer Park with a picnic table, ADA compliant and low maintenance.
- 4. Contract for Pest Control Company still under discussion.
- 5. President Hill presented the concept of a card key system to replace the locks and keys currently in place on our front gates and buildings. This card key is very much like those used on hotel rooms There have been many problems in the past with lost keys, keys with apt. Residents and vandalism to the locks themselves to gain entrance. It has been a costly and frustrating problem that needs a new solution. Discussion will continue on this at the July Board Meeting. –Staff Reporter-
